UNAUTHORIZED PRACTICE OF LAW

The following policy pertains to agency conduct, staff, contracted individuals and volunteer conduct and training related to the unauthorized practice of law.

WI FACETS Agency Conduct:

- 1. WI FACETS, Inc. is not a law firm or legal services agency.
- 2. WI FACETS, Inc. will not provide any type of services that may be construed as practicing law, including but not limited to: giving legal advice, drafting legal documents or representing individuals/families in any type of legal proceeding.
- 3. WI FACETS, Inc. will provide its staff members, contracted individuals, and volunteers with regular, appropriate training concerning the unauthorized practice of law.
- 4. WI FACETS, Inc. will provide staff members, contracted individuals, and volunteers with unauthorized practice of law disclaimers that may be read to callers and meeting participants.
- 5. WI FACETS, Inc. will include a disclaimer on its website advising viewers that the information contained on the website is not a substitute for legal advice or representation.
- 6. WI FACETS, Inc. will include a standard disclaimer on its records authorization form cover letter.
- 7. WI FACETS, Inc. will make continuing efforts to build a roster of attorneys who are available to take legal referrals from WI FACETS, Inc. on a pro bono or reduced fee basis.

Staff, Contracted Individuals and Volunteer Conduct:

- 1. Staff members, contracted individuals and volunteers will not provide any type of services that may be construed as practicing law, including but not limited to: giving legal advice, drafting legal documents, or representing individuals/ families in any type of legal proceeding.
- 2. Staff members, contracted individuals and volunteers will attend not less than one training per year concerning the unauthorized practice of law.
- 3. Staff members, contracted individuals and volunteers will use the unauthorized Practice of law disclaimers that WI FACETS, Inc. provides to them.
- 4. Staff members, contracted individuals and volunteers will make legal referrals, using the roster of attorneys provided to them, when necessary.

Training:

- 1. WI FACETS, Inc. will provide training to its staff members, contracted individuals, and volunteers, at least one time per year, concerning the unauthorized practice of law.
- 2. Unauthorized practice of law trainings, which are sponsored by WI FACETS, Inc. will be performed by a licensed attorney.
- 3. A copy of Wisconsin's current law concerning the unauthorized practice of law or practicing law without a license shall be provided to training participants.

THIS POLICY SHALL BE REVIEWED AT LEAST ANNUALLY BY THE BOARD.
