



**IDEA Dispute Resolution Data Summary for:**  
**Arkansas**  
**2010-11 to 2020-21**

The Individuals with Disabilities Education Act (IDEA) requires states and entities receiving IDEA grants to make available four dispute resolution processes and report annually on each to the U.S. Department of Education Office of Special Education Programs (OSEP). The four dispute resolution processes include written state complaints, mediation, due process complaints, and resolution meetings associated with due process.

The purpose of this summary is to provide a historical look at dispute resolution data and to assist with the identification of trends and changes in the use of the IDEA dispute resolution processes over time. Additional summaries can be found on the CADRE website at:

This summary features data for school years ("SY" July 1-June 30) 2010-11 through 2020-21 drawn from CADRE's National Longitudinal Database. Data are collected from the following sources: [1] from SY 2010 to the present, Section 618 data collected by the Data Accountability Center (DAC) and, as of SY 2011, reported to EDfacts; [2] data published in OSEP's Annual Report to Congress; and [3] data adjustments collected from states by CADRE after OSEP data were locked.

CADRE examines dispute resolution data for internally inconsistent values (based on report element definitions). When inconsistent values are found they are reconciled with OSEP. States are encouraged to submit notes or explanations regarding any conditions, anomalies, or corrections relating to the data included herein. 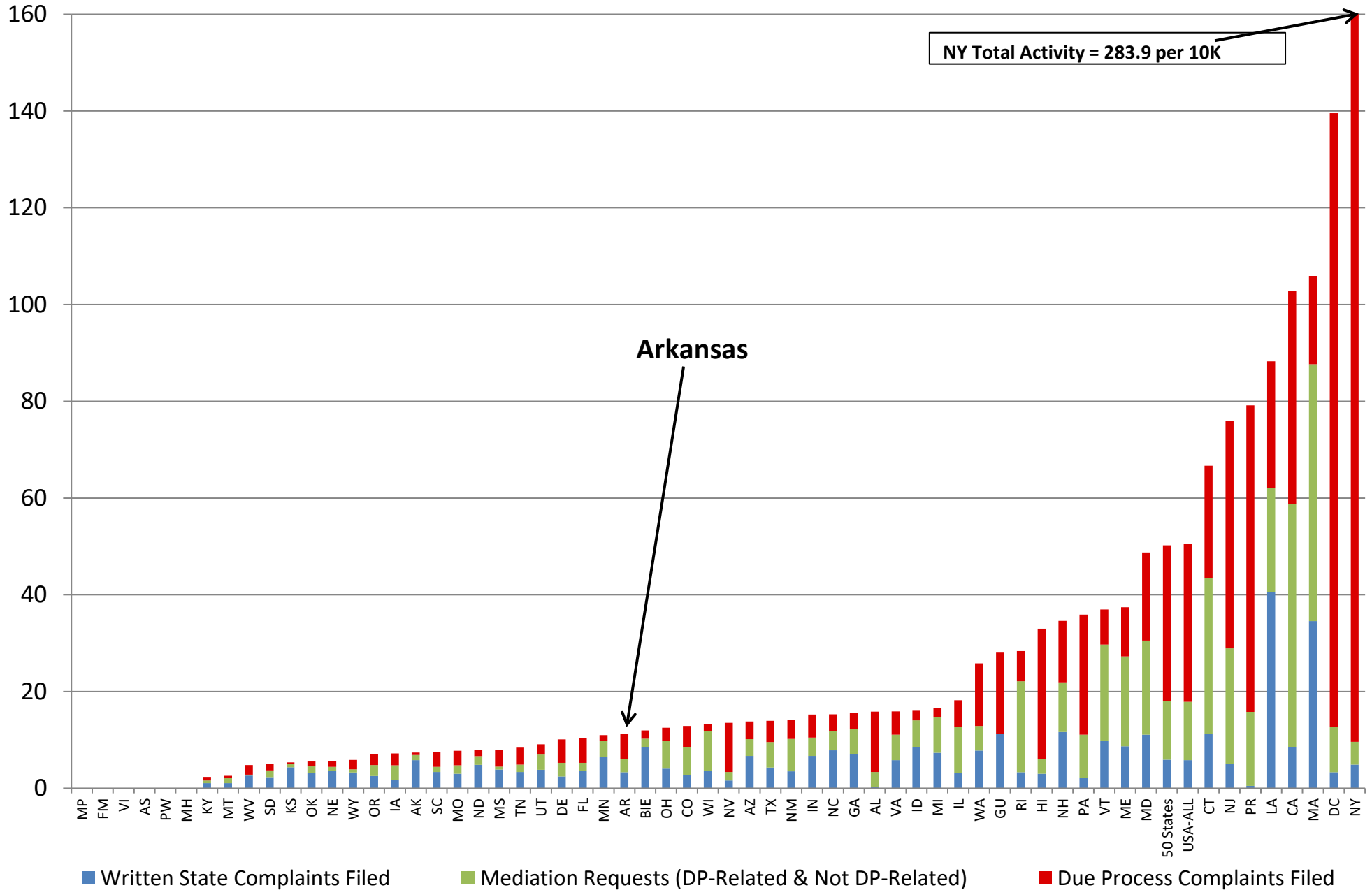

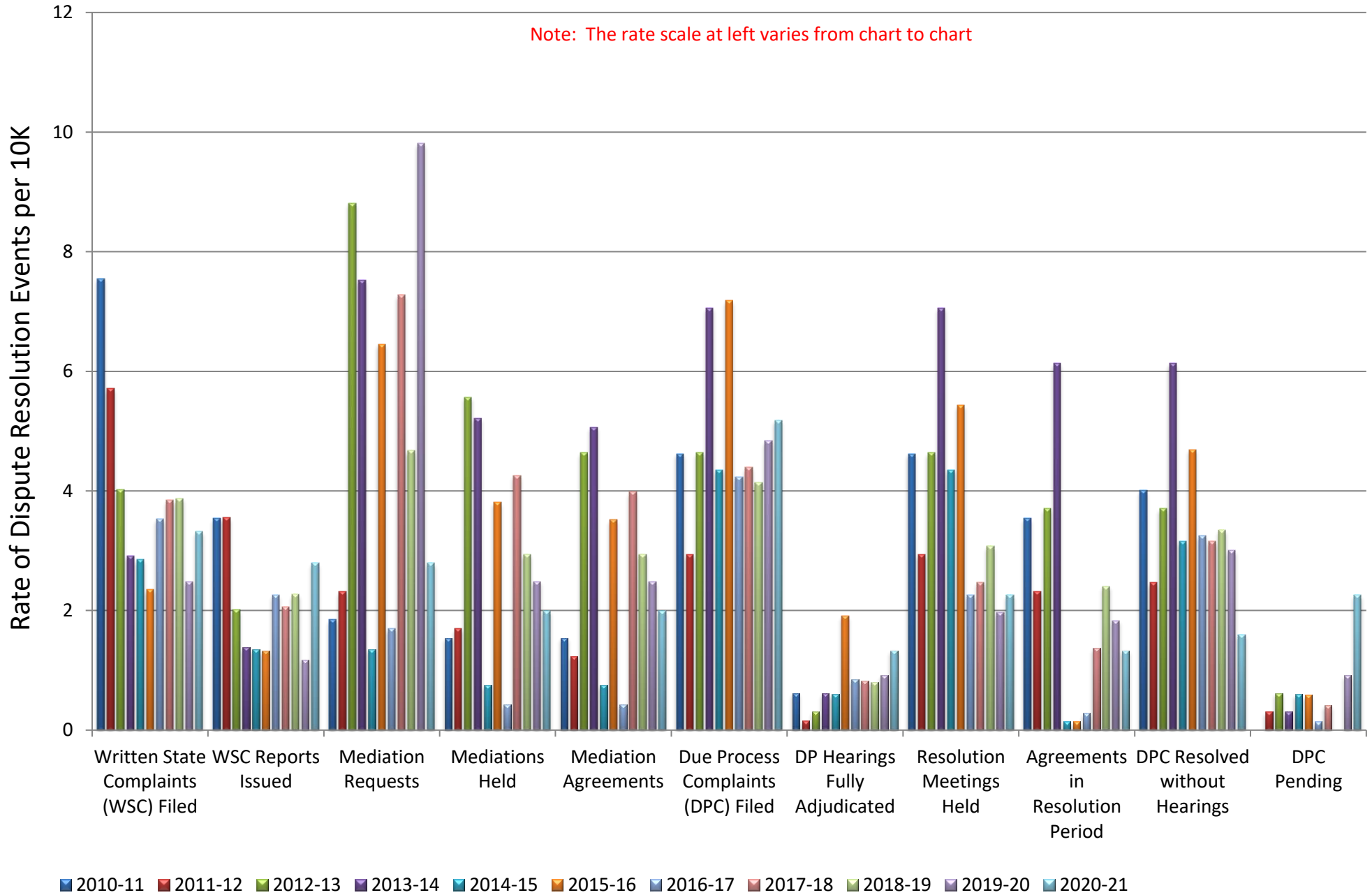


# Total Dispute Resolution Activity by State/Entity per 10K Child Count: 2020-21

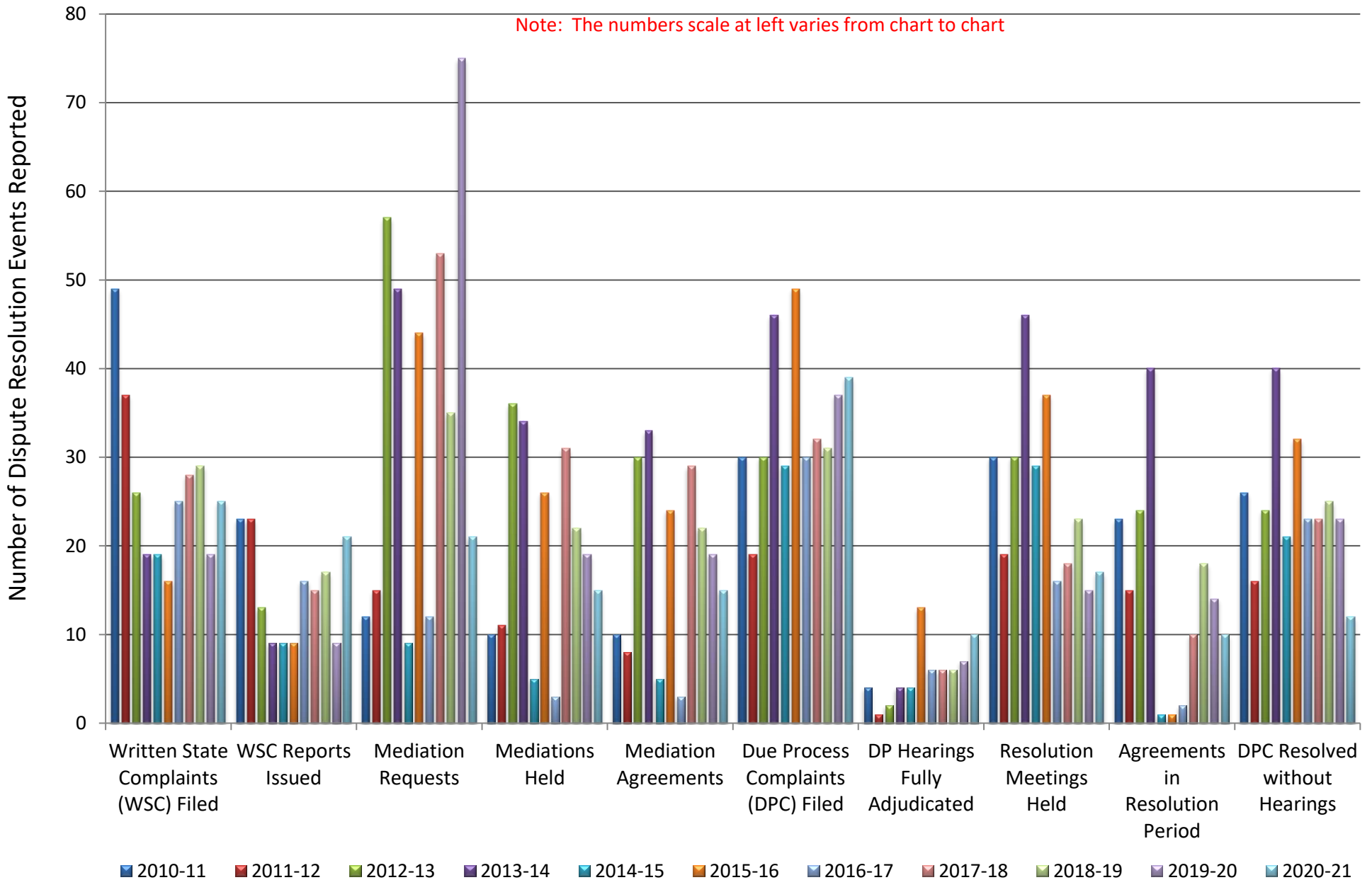




# IDEA Dispute Resolution Activity per 10K Child Count: Arkansas

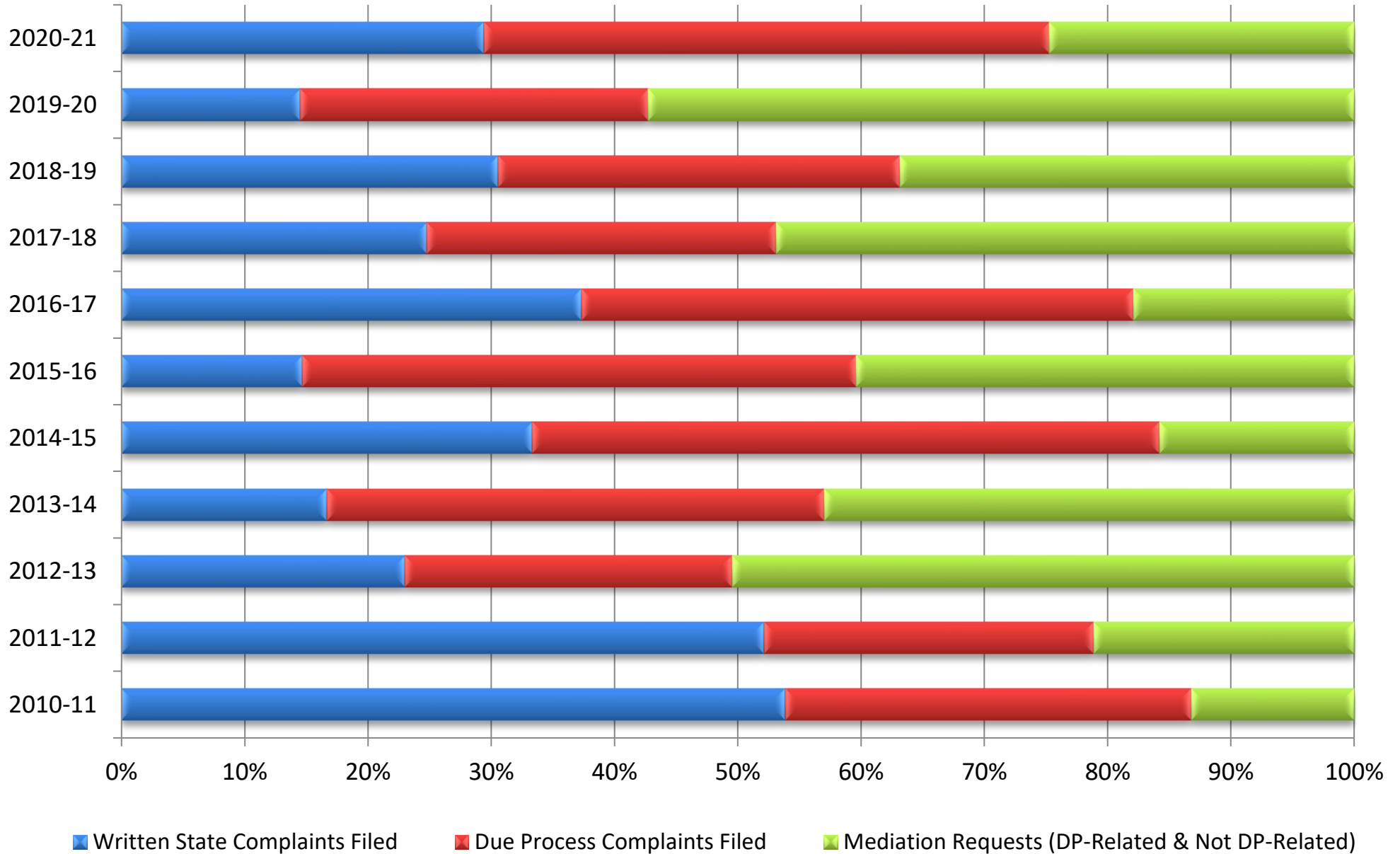


# IDEA Dispute Resolution Activity: Arkansas

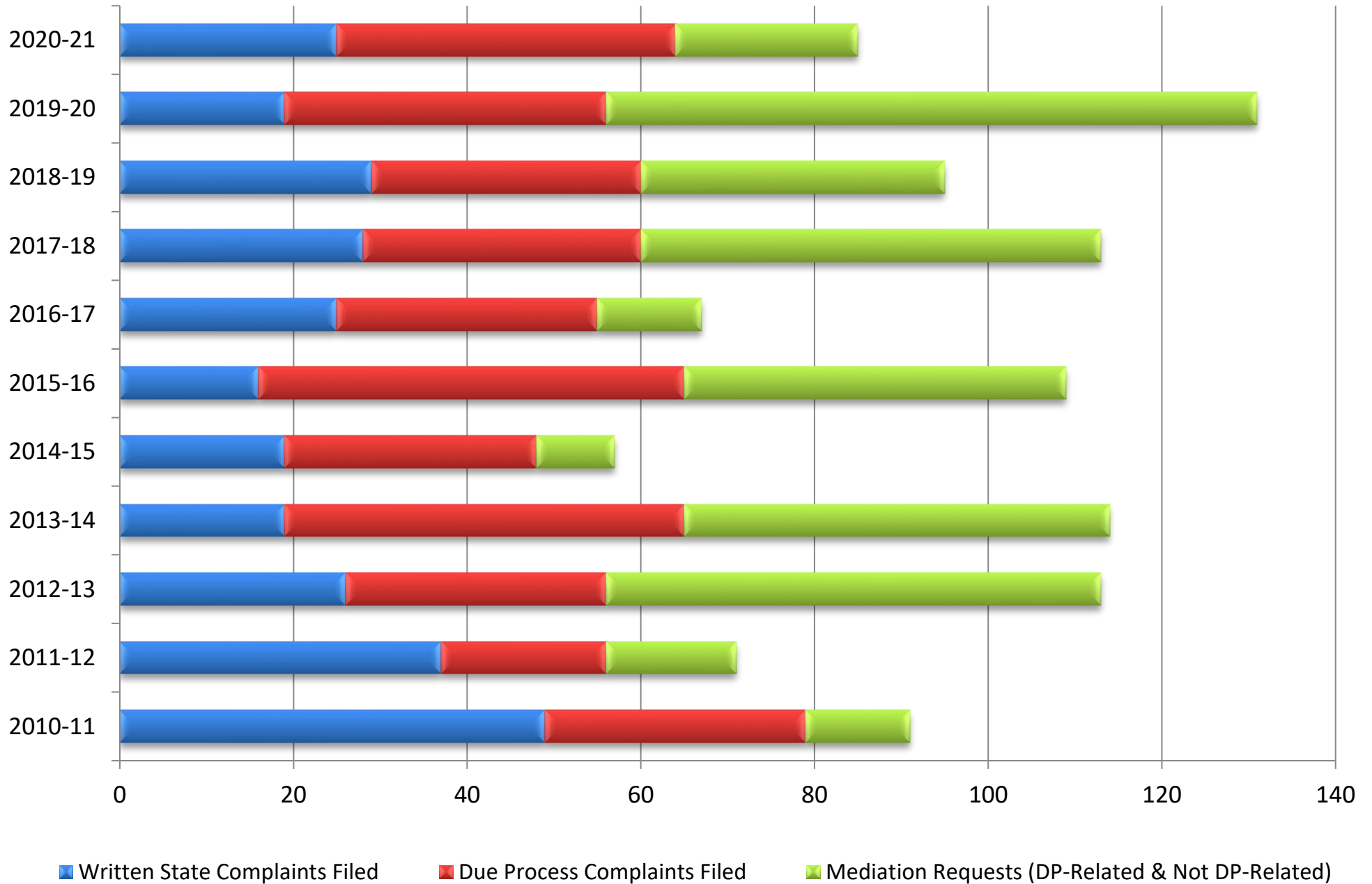


# Relative Use of Dispute Resolution Options: Arkansas

Note: 100% = The sum of requests for all dispute resolution processes

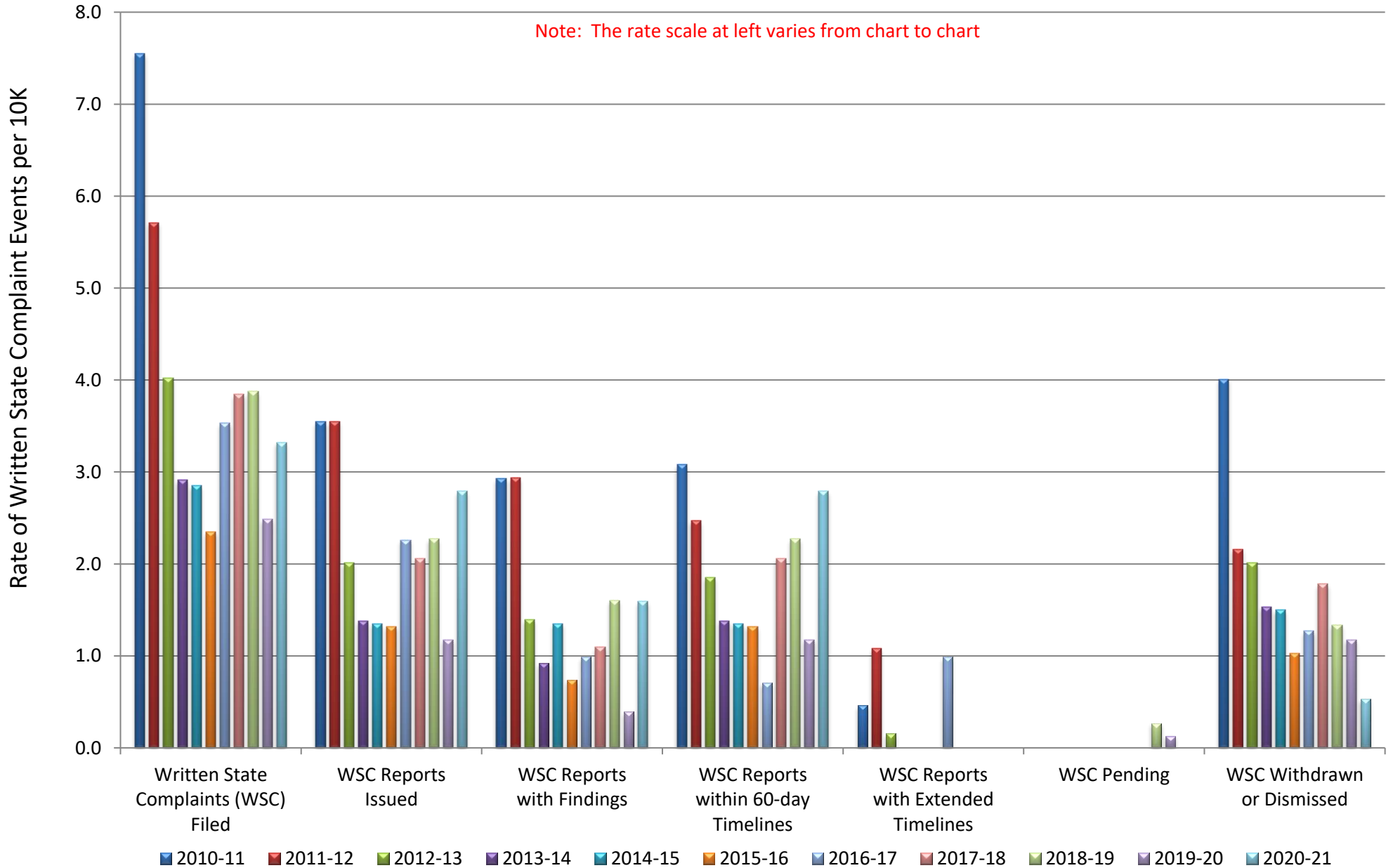


## Aggregate Use of Dispute Resolution Options: Arkansas



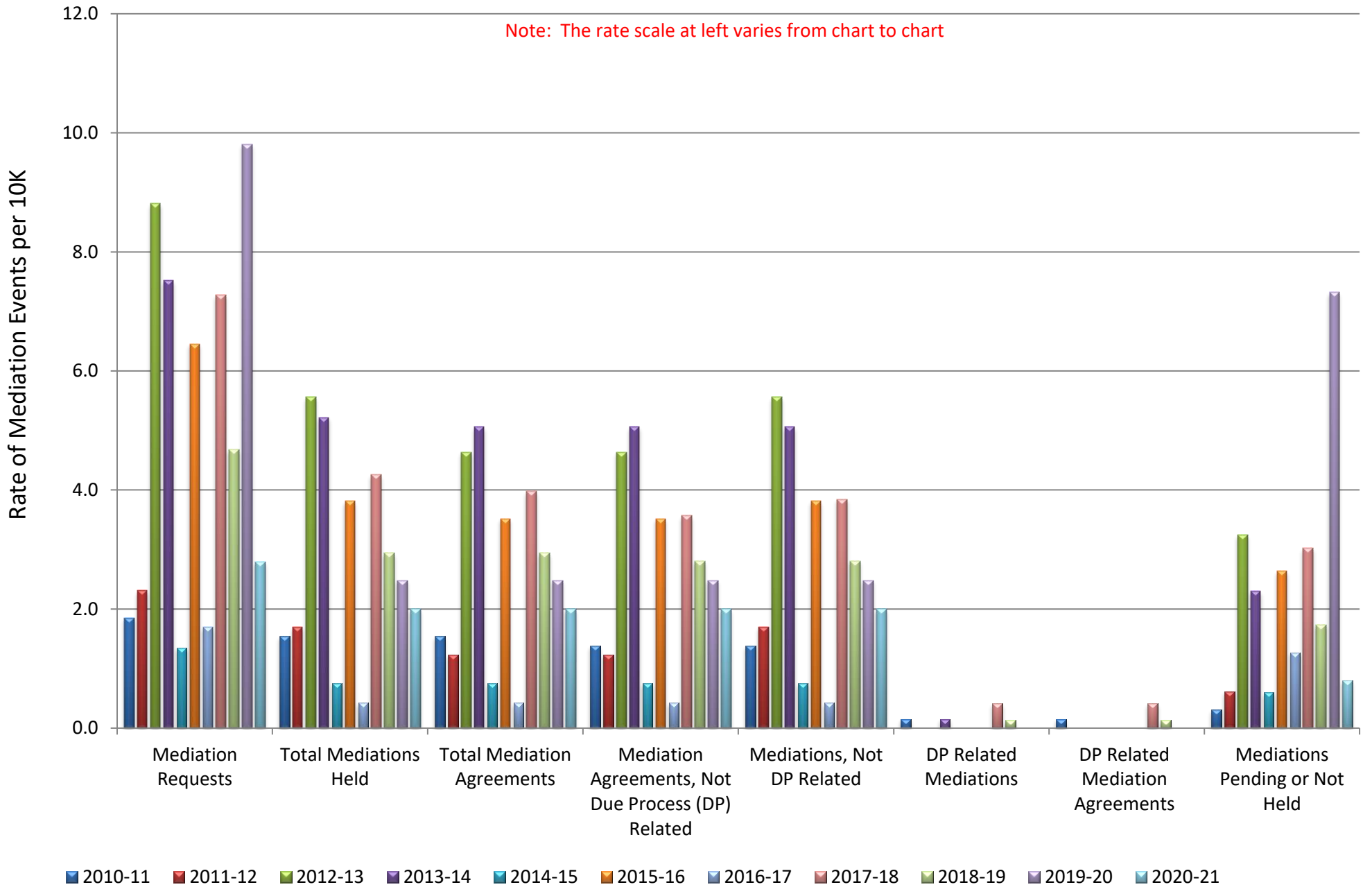


# Written State Complaint Activity per 10K Child Count: Arkansas



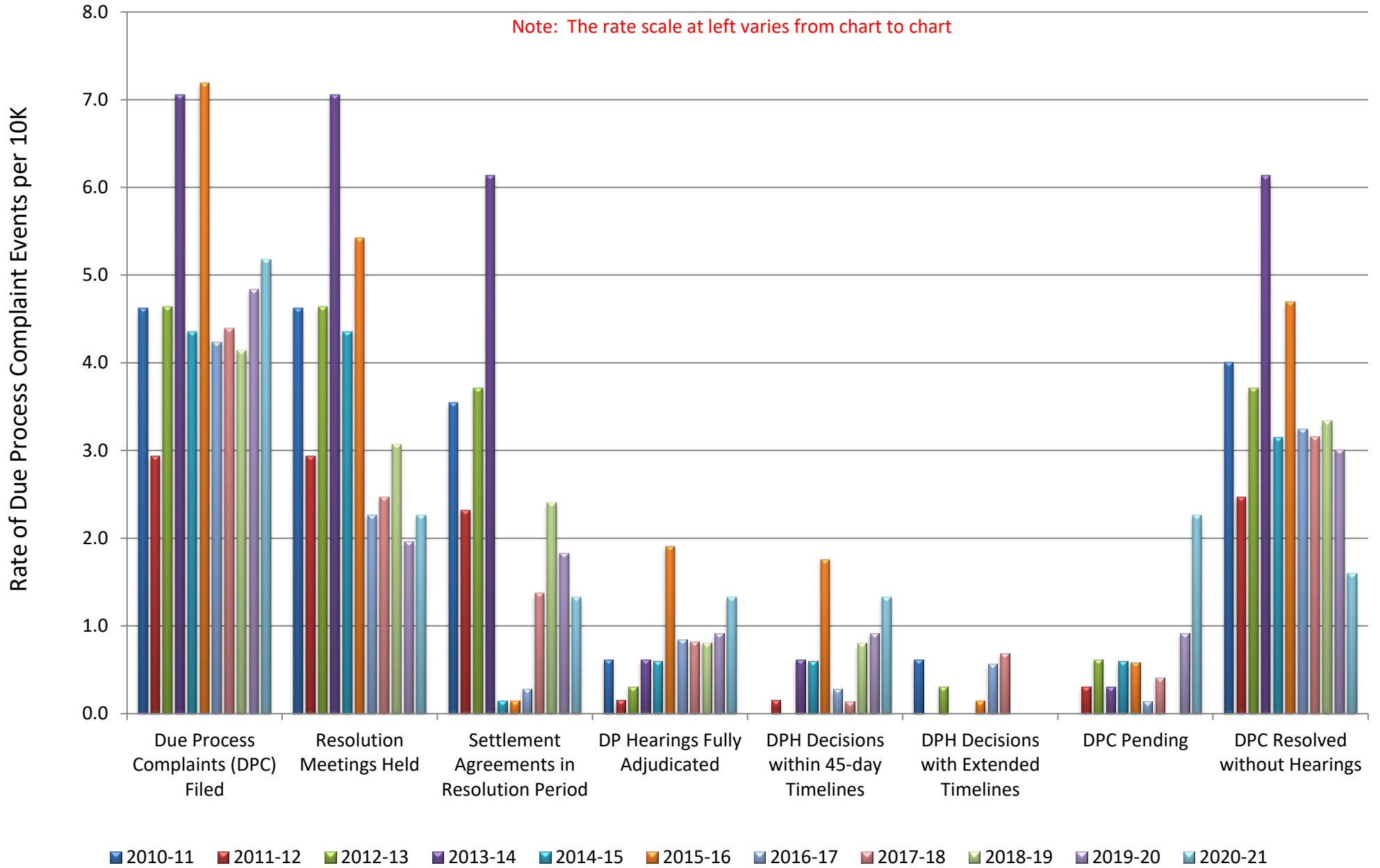


# Mediation Activity per 10K Child Count: Arkansas



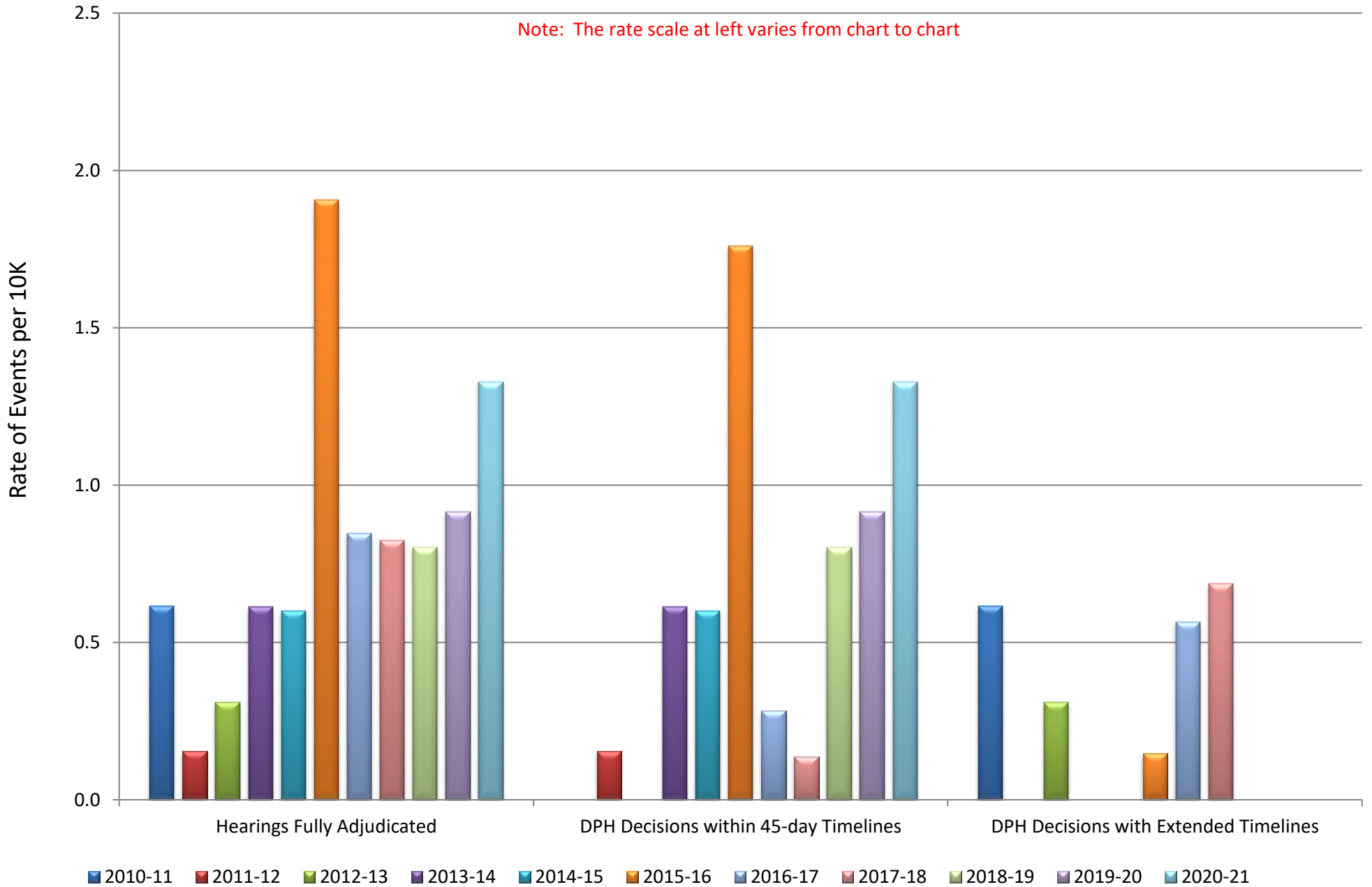


# Due Process Complaint Activity per 10K Child Count: Arkansas



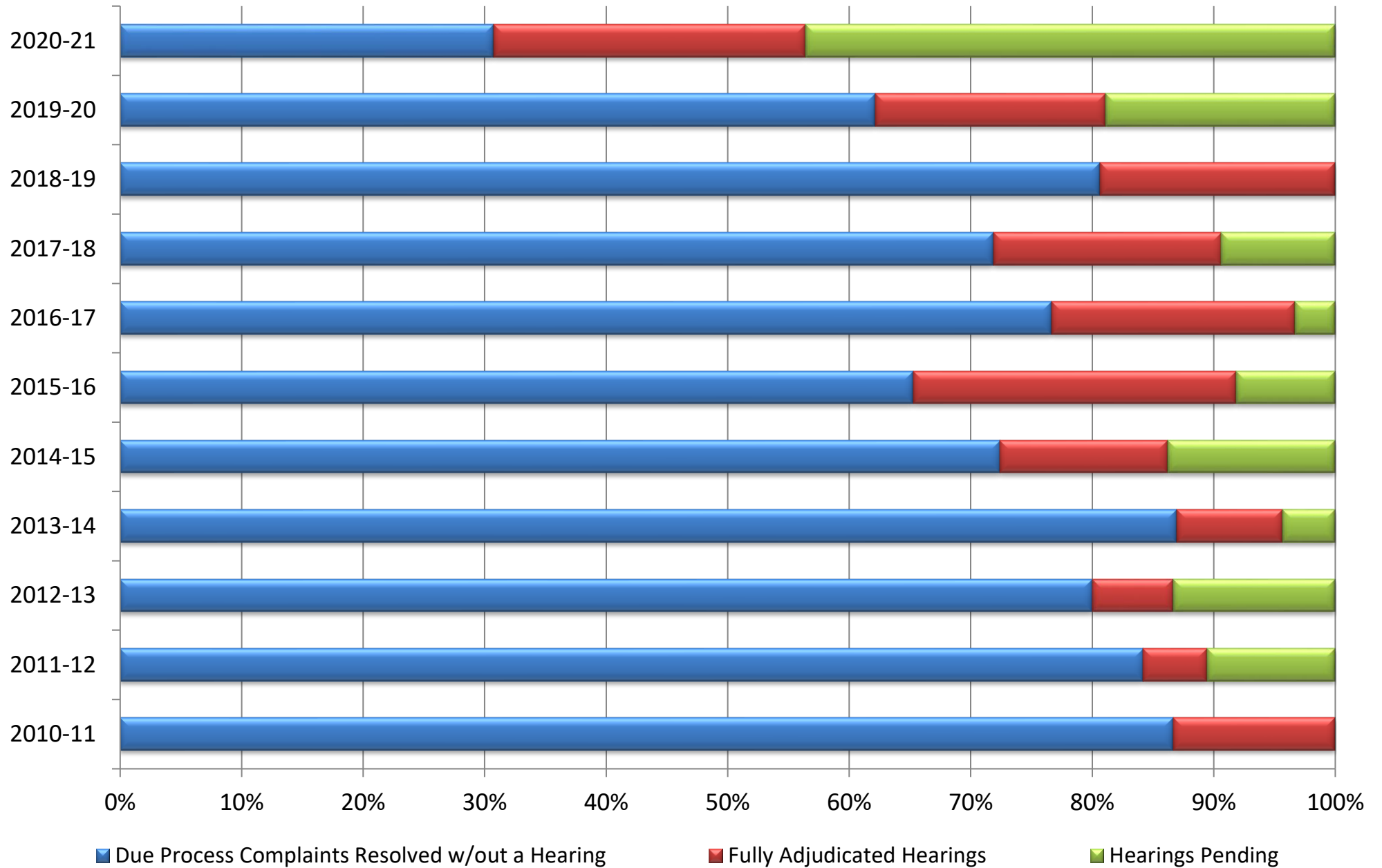


# Timeliness of Due Process Hearing Decisions per 10K Child Count: Arkansas
